### Day 1: Kilimanjaro

24<sup>th</sup> January 2019

Arrive at Kilimanjaro International Airport. It is here you will meet your host Bobby-Jo Vial and begin your exciting photographic safari adventure.

We start the adventure with a drive to our first night's quality camp accommodation (twin share).

*You will need to make sure that your flight into Kilimanjaro (JRO) arrives before 16:00 as we have a 3-hr drive to our accommodation. If you cannot arrive before 16:00 we suggest that you arrive on the 23<sup>rd</sup> of January and stay overnight in Arusha. We can provide information on hotels to book.*

### Day 2: Photography Lessons

25<sup>th</sup> January 2019

Today we have a full day to relax and learn all about wildlife photography. We have dedicated this day to start our photographic lessons. These early lessons will come in very handy for when we enter the Serengeti on our first drive. We will have the chance to photograph local wildlife and also relax by the pool and enjoy our gorgeous surroundings.

## Day 3: Serengeti

26<sup>th</sup> January 2019

After an early breakfast, we will make our way towards to the Southern Serengeti plains with a game drive en-route.

We will catch our first glimpse of the world famous Ngorongoro Crater at our lunch spot and then will spend the rest of the afternoon on a spectacular and unforgettable drive through the Ngorongoro Conservation Area which will lead us to the Serengeti National Park.

Overnight in quality tented camp accommodation (twin share).

All meals are included throughout.

### Serengeti

The Maasai called the plains of Serengeti National Park "the place where the land moves on forever" - so prepare to be astonished by its vastness. And here, you can witness the famous Serengeti annual migration, the largest and longest overland migration on earth.

The Serengeti ecosystem is one of the oldest on earth. The essential features of climate, vegetation and fauna have barely changed in the past million years. Early man himself made an appearance in the Olduvai Gorge about two million years ago. Some patterns of life, death, adaptation and migration are as old as the hills themselves.

It is the migration for which the Serengeti is perhaps most famous. Over a million wildebeest and about 200,000 zebra flows south from the northern hills to the southern plains for the short rains every October and November, and then swirl west and north after the long rains in April, May and June. So, strong is the ancient instinct to move that no drought, gorge or crocodile infested river can hold them back.

The wildebeest travel through a variety of parks, reserves and protected areas and through a variety of habitat.

## Day 4: Central Serengeti

27<sup>th</sup> January 2019

We spend the day discovering the Central Serengeti. The Seronera Valley is renowned for its abundance of wildlife especially its resident lions and leopards. It is an absolute hotspot for wildlife with its permanent water source. Areas that we may visit include Moru Kopjes & Gol Kopjes which are both prime lion breeding habitat.

Today we will continue our photographic lessons and coaching.

## Day 5,6,7,8: Ndutu

28<sup>th</sup>, 29<sup>th</sup>, 30<sup>th</sup>, 31<sup>st</sup> January 2019

Today we move across to the Ndutu plains which are located in the Ngorongoro Conservation Area. We spend the next four days on morning and afternoon game drives looking for incredible wildlife opportunities. Photographic & image editing lessons will take place during the middle of the day in the comfort of our lodge.

4 Nights are spent in quality lodge accommodation (twin share).

## Ndutu & The Southern Serengeti Plains

Each year around the same time, the great circular wildebeest migration begins in the Ngorongoro Conservation Area of the Southern Serengeti in Tanzania. The initial phase lasts from approximately January to March, when the calving season begins – a time when there is plenty of rain-ripened grass available for the 260,000 zebra that precede 1.7 million wildebeest and the following hundreds of thousands of other plains game.

During February, the wildebeest spend their time on the short grass plains of the Southern Serengeti including Ndutu, grazing and giving birth to approximately 500,000 calves within a 2 to 3-week period. This birthing frenzy attracts the highest concentration of predators in the world.



### Day 9: Ngorongoro Crater

1<sup>st</sup> February 2019

Today we travel to the world famous Ngorongoro Crater but not without one last morning game drive on the Ndutu Plains.

We have lunch before heading to the Ngorongoro Highlands where we will spend the next two nights right on the crater rim.

Overnight in quality lodge accommodation on the rim of the Ngorongoro Crater (twin share).

All meals are included throughout.



## Ngorongoro Crater

Approximately 2.5 million years ago, the Ngorongoro Crater was a huge volcanic mountain, rivaling Kilimanjaro in size. This changed when the top of the mountain collapsed in on itself, creating the biggest volcanic caldera in the world and an absolute oasis for wildlife!

The Crater is possibly the best place in all of Tanzania to see the Big Five. A healthy population of black rhino and some of the largest tusked elephants left in the country. The crater is also home to lions, leopards and hyena along with healthy herds of resident wildebeest, buffalo and zebra. The crater also boasts over 400 species of bird.



Day 10: Ngorongoro Crater

2<sup>nd</sup> February 2019

Today we will spend an unforgettable day on the floor of the Ngorongoro Crater. We will be searching for the Crater's famous lion prides, black rhino and tusker elephants among many other incredible species.

We will have a picnic breakfast and lunch at a scenic spot inside the crater.

Overnight in quality lodge accommodation on the rim of the Ngorongoro Crater (twin share).

## Cancellations

In the event that you may have to cancel your safari booking then this cancellation notice will need to be made in writing and

- For cancellations **made more than 90 days** prior to start date: **30%** cancellation penalty will apply (i.e. full deposit).
- For cancellation **made less than 90 days** prior to departure date: **100%** cancellation penalty will apply (i.e. the full booking cost).

### Why is your deposit non-refundable?

Sometimes things just don't work out for whatever reason. Plans made this year may need to be changed for medical or personal reasons. However, as soon as you confirm your place on a Duma Safaris tour with your 30% deposit amount these funds are immediately distributed amongst the many lodges, camps & suppliers that are used to make up a successful and memorable safari. It locks in the required services for particular dates often in peak season that the camps or suppliers cannot then offer to other travellers.

Your decision to change your plans might be made months out from the start and often travellers will question – Why can't you just get someone else to take my spot? It is a valid question but sometimes not that easy. The moment we secure those services we are locked in for the safari arrangements for our whole group. Permits & park passes are issued and if we are unable to find other travellers to fill a cancelled spot then Duma Safaris is left with paid services and no one to fill them. Additional marketing and promotion expenses are also incurred trying to find other interested travellers.



## Travel Insurance

For every traveller that participates in any Duma Safaris experience it is a non-negotiable requirement that they purchase and carry a comprehensive travel insurance policy.

It is advised this policy is taken out at the time of paying your deposit to cover you for any unfortunate or unforeseen events either before or during the tour that may affect your plans and therefore could possibly cover cancellation costs incurred.

As outlined in **Why is your deposit non-refundable?** the 30% deposit required to secure your place on a specific safari is non-refundable. If your plans have to be cancelled due to a medical issue or personal reason that is covered under your travel insurance policy then a claim can be made via your travel insurance provider and they will assess whether you qualify for a refund through your travel insurance policy.

Please note that travel insurance policies do not process claims or issue refunds should a traveller change their mind or just want to change their plans.

Duma Safaris will not be liable for any costs resulting from any traveller's failure to purchase sufficient travel insurance and all travellers participating in any tour are required to sign the booking form at the end of this document containing our full terms and conditions.

## Vaccinations

Duma Safaris also recommends visiting your personal GP or travel vaccination service as soon as booking your safari to discuss your personal requirements that may be required in the form of injections or medications whilst travelling in Africa. Vaccinations and medications will vary from person to person and only your GP or medical service can provide up to date and accurate information for your specific needs. Included in these discussions should be topics such as but not limited to Malaria, Yellow Fever & Hepatitis etc.

# Tour Terms & Conditions

## 1. ACCEPTANCE

- 1.1 These Terms are between Duma Safaris Pty Ltd (ABN 89 614 116 666), its successors and assignees (referred to as “we”, “us” or “our”) and you, the person, organisation or entity described in the Booking Form (referred to as “you” or “your”), and collectively the Parties. These Terms apply to all Services provided by us to you.
- 1.2 You have requested the Services set out in the attached Booking Form. You accept the Booking Form and these Terms by signing and returning the Booking Form.
- 1.3 **You agree that these Terms form the agreement under which we will supply Services to you. Please read these Terms carefully.** Please contact us if you have any questions using the contact details at the end of these Terms. Purchasing Services from us indicates that you have had sufficient opportunity to read these Terms and contact us if needed, that you have read, accepted and will comply with these Terms, and that you are 18 years or older, or have the consent of a legal guardian who is 18 years or older. You must not order or use the Services if you are under 18 years of age or do not have the consent of a legal guardian who is 18 years or older. If you do not agree to these Terms, you must not use or purchase our Services from us.
- 1.4 We will not commence performing the Services until you have paid the Deposit or first instalment of our Fees.

## 2. SERVICES

- 2.1 We agree to perform the Services with due care and skill.

- 2.9 If you request a Variation, we have discretion as to whether we perform this work for you and whether an adjustment to the Fee may be required in respect of the same. If we are unable to accommodate the Variation, we may request that we be paid for Services performed to date and terminate these Terms.
- 2.10 If we agree to perform a Variation, then we will inform you of any Variation Fee. You must pay the Variation Fee before we commence work on the Variation. We will invoice you accordingly for the Variation.
- 2.11 For the avoidance of doubt, requesting any changes to the participant details set out in the Booking Form constitutes a Variation and is likely to result in a Variation Fee.
- 2.12 We reserve the right to make changes to the Services, including camps, lodges and third party services, if we are unable to provide them as set out in the Booking Form, itinerary or elsewhere. If we make changes to Services we will make all reasonable efforts to discuss these with you.

- 4.1 You warrant that you will not employ, canvass, solicit, entice, induce or attempt to employ any employee or contractor that was employed by or contracted to us during the time that we provided Services to you or during the 12 month period prior to that time.
- 4.2 You warrant that throughout the term of these Terms that:
  - (a) there are no legal restrictions preventing you from agreeing to these Terms;
  - (b) you will cooperate with us, and provide us with information that is reasonably necessary to enable us to perform the Services, as requested by us from time to time, and comply with these requests in a timely manner;
  - (c) you will follow our safety instructions and those of our employees, contractors, agents and third party providers at all times;
  - (d) the information you provide to us is true, correct and complete;
  - (e) you will not infringe any third party rights in working with us and receiving the Services;
  - (f) you will inform us if you have reasonable concerns relating to our provision of Services under these Terms, with the aim that we and you will use all reasonable efforts to resolve your concerns;
  - (g) you are responsible for obtaining any consents, licences and permissions from other parties necessary for the Services to be provided, at your cost, and for providing us with the necessary consents, licences and permissions;
  - (h) you hold travel insurance that specifically covers the countries and activities in the Services and will provide evidence of such insurance to us if we request it; and
  - (i) you consent to the use of your personal information in relation to the Services.
- 4.3 You are expected to conduct yourself in an orderly and acceptable manner and not to disrupt the enjoyment of other guests. If in our opinion or in the opinion of any hotel manager or any other person in authority, your behaviour or that of any member of your party is causing or is likely to cause distress, danger or annoyance to any of our other guests or any third party or damage to property, or to cause a delay or diversion to transportation, we reserve the right to terminate your booking arrangements with us immediately. In the event of such termination our liability to you will cease, you will be required to leave your accommodation or other service immediately and we will have no further obligations to you.

#### **5. PASSPORTS, VISAS AND HEALTH**

- 5.1 You are responsible for arranging your own passport, visa and health requirements including vaccinations.
- 5.2 Visa requirements can and do change and we recommend that you recheck the visa requirements for your destination prior to travel. If you are not travelling on an Australian passport, a returning resident visa may be required for re-entry into Australia. It is your responsibility to obtain this. Please also note that some countries require a specific visa type for persons who have had a previous criminal conviction. If you require further information about this, please contact the relevant foreign embassy for further information.
- 5.3 Some countries require that your passport be valid for 6 months beyond the date of your intended stay in the country and you must ensure that your passport is still current for travel. Please also check that the photo page of your passport is not frayed or lifting as you may also be turned away at check-in.



Furthermore, a “machine readable” passport may be required and you should contact the relevant foreign embassy for clarification.

- 5.4 The name on the airline ticket must be identical to your passport and you are responsible for ensuring that this is the case at the time that you make a booking.
- 5.5 You should see a travel doctor regarding the vaccinations required for your travel. You should also speak with the relevant foreign embassies, as some countries require that travellers be vaccinated against specific diseases.
- 5.6 The Australian Department of Foreign Affairs and Trade (DFAT) provides a travel advisory service and advises Australian travellers on security risks in a number of countries. Please contact DFAT to avail yourself of the travel advisories prior to departure. Please refer to this guide at: [www.smartraveller.gov.au](http://www.smartraveller.gov.au).
- 5.7 We do not accept any responsibility or liability if you cannot travel, or incur any other loss because you have not complied with any passport, visa, immigration requirements or health formalities.
- 5.8 You agree to reimburse us in relation to any fines or other losses which we incur as a result of your failure to comply with any passport, visa, immigration requirements or health formalities.

## **6. OUR INTELLECTUAL PROPERTY**

- 6.1 The Materials contain material which is owned by or licensed to us and is protected by Australian and international laws. We own the Intellectual Property rights in the Materials including but not limited to copyright which subsists in all creative and literary works incorporated into our Materials.
- 6.2 You agree that, as between you and us, we own all Intellectual Property rights in our Materials, and that nothing in these Terms constitutes a transfer of any Intellectual Property rights in our Materials, except as stated in these Terms or with our written permission.
- 6.3 Your use of our Materials does not grant you a licence, or act as a right to use any Intellectual Property in the Materials, whether registered or unregistered, except as stated in these Terms or with our written permission.
- 6.4 You must not breach our Intellectual Property rights by, including but not limited to:
  - (a) altering or modifying any of the Materials;
  - (b) creating derivative works from the Materials; or
  - (c) using our Materials for commercial purposes such as onsale to third parties.

## **7. CONFIDENTIAL INFORMATION**

- 7.1 We, including our employees and contractors, agree not to disclose your Confidential Information to any third party (other than where necessary, to third party suppliers, or as required by law); to use all reasonable endeavours to protect Confidential Information from any unauthorised disclosure; only to use the Confidential Information for the purpose for which it was disclosed by you and ancillary business purposes, and not for any other purpose.
- 7.2 You, including your employees and contractors, agree not to disclose our Confidential Information to any third party; to use all reasonable endeavours to protect Confidential Information from any unauthorised disclosure; and only to use the Confidential Information for the purpose for which it was disclosed or provided by us to you, and not for any other purpose.
- 7.3 These obligations do not apply to Confidential Information that:
  - (a) is authorised to be disclosed;
  - (b) is in the public domain and/or is no longer confidential, except as a result of breach of these Terms;
  - (c) is received from a third party, except where there has been a breach of confidence; or
  - (d) must be disclosed by law or by a regulatory authority including under subpoena.
- 7.4 This clause will survive the termination of these Terms.

## **8. FEEDBACK AND DISPUTE RESOLUTION**

- 8.1 Your feedback is important to us. We seek to resolve your concerns quickly and effectively. If you have any feedback or questions about the Services, please contact us.
- 8.2 If there is a dispute between the Parties in relation to these Terms, the Parties agree to the following dispute resolution procedure:
  - (a) The complainant must tell the respondent in writing, the nature of the dispute, what outcome the complainant wants and what action the complainant thinks will settle the dispute. The Parties agree to meet in good faith to seek to resolve the dispute by agreement between them at an initial meeting.



(b) If the Parties cannot agree how to resolve the dispute at that initial meeting, any Party may refer the matter to a mediator. If the parties cannot agree on who the mediator should be, the complainant will ask the Law Society of New South Wales to appoint a mediator. The mediator will decide the time and place for mediation. The Parties must attend the mediation in good faith, to seek to resolve the dispute.

8.3 Any attempts made by the Parties to resolve a dispute pursuant to this clause are without prejudice to other rights or entitlements of the Parties under these Terms, by law or in equity.

## 9. TERM AND TERMINATION

9.1 This Agreement will begin when we sign the Booking Form and continue until the End Date, or the date on which these Terms are terminated in accordance with this clause, if earlier.

9.2 Either Party may terminate these Terms, if there has been a material breach of these Terms, subject to the dispute resolution procedure in these Terms.

9.3 If you cancel your booking more than 90 days prior to the Departure Date you acknowledge that the Deposit may not be refundable to you. If you cancel your booking later than 90 days prior to the Departure Date you acknowledge that any refund of the Price paid will be at our discretion and will depend on our being able to recover out costs by filling your place.

9.4 If we need to cancel or vary the Services due to circumstances beyond our control you may be liable for extra costs for the new arrangements made on your behalf including, but not limited to, travel and alternative accommodation costs.

9.5 We may terminate these Terms immediately, at our sole discretion, if:

- (a) we consider that a request for the Service is inappropriate, improper or unlawful;
- (b) you fail to provide us with clear or timely instructions to enable us to provide the Services;
- (c) we consider that our working relationship has broken down including a loss of confidence and trust;
- (d) for any other reason outside our control which has the effect of compromising our ability to perform the work required within the required timeframe; or
- (e) you fail to pay an invoice within 10 Business Days of the payment date as set out in the Invoice Terms.

9.6 On termination of these Terms you agree to promptly return (where possible), or delete or destroy (where not possible to return), our Confidential Information and Intellectual Property, and/or documents containing or relating to our Confidential Information and Intellectual Property.

9.7 On completion of the Services, we will retain your documents (including copies) as required by law or regulatory requirements. Your express or implied agreement to these Terms constitutes your authority for us to retain or destroy documents in accordance with the statutory periods, or on termination of these Terms.

9.8 The accrued rights, obligations and remedies of the Parties are not affected by the termination of these Terms.

## 10. CONSUMER LAW, LIMITATION OF LIABILITY AND DISCLAIMERS

10.1 **ACL:** If you are a consumer as defined in the ACL, the following applies to you: *You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the services remedied if they are not rendered with due care and skill or they are not fit for purpose and the failure does not amount to a major failure.*

10.2 **Delay:** Where the provision of Services depends on your information or response, we have no liability for a failure to perform the Services in the period set out in the Booking Form where it is affected by your delay in response, or supply of incomplete or incorrect information.

10.3 **Third party specialists:** We may provide you with contact details of third party specialists. This is not a recommendation by us for you to seek their advice or to use their services. We make no representation or warranty about the third party advice or provision of services, and we disclaim all responsibility and liability for the third party advice or provision of services, or failure to advise or provide services.

10.4 **Warranties:** To the extent permitted by law, we exclude all express and implied warranties representations and guarantees and all material and work is provided to you without warranties, representations and guarantees of any kind, either express or implied. We expressly exclude all warranties including but not limited to implied warranties of merchantability and fitness for a particular purpose.



- 10.5 **Liability Release:** You acknowledge that travel as part of receiving the Services can be dangerous including, but not limited to, hazards from travelling by any form of vehicle, accident or illness in remote areas without access to medical facilities or evacuation, forces of nature, acts of God and civil disturbance. You further acknowledge that animal encounters can be dangerous and can cause illness and injury and in some cases death. You agree to release us and indemnify us against any Claims for all losses or damages, personal injury or death you may incur whilst receiving the Services.
- 10.6 **Liability:** To the extent permitted by law, we exclude all liability for any Claims (whether direct, indirect, incidental, special, consequential and/or incidental) for personal injury, death, loss of profits, revenue, production, opportunity, access to markets, goodwill, reputation or any loss or damage relating to business interruption or otherwise, suffered by you or made against you, arising out of or in connection with your use of the Services, even if we were expressly advised of the likelihood of such loss or damage.

- 11.1 You are liable for and agree to indemnify, defend and hold us harmless for and against any and all Claims, liabilities, suits, actions and expenses, including costs of litigation and reasonable legal costs, resulting directly or indirectly from:
- (a) any information provided by you that is not accurate, up to date or complete or is misleading or a misrepresentation;
  - (b) any breach of these Terms by you;
  - (c) any misuse of the Services by you, your employees, contractors or agents; and
  - (d) your breach of any law or third party rights.
- 11.2 You agree to co-operate with us (at your own expense) in the handling of disputes, complaints, investigations or litigation that arise as a result of your use of the Services including but not limited to disputes, complaints, investigations or litigation that arises out of or relates to incorrect information you have given us.
- 11.3 This clause will survive the termination of these Terms.
- 12. GENERAL**
- 12.1 **Privacy:** We agree to comply with the legal requirements of the Australian Privacy Principles as set out in the *Privacy Act 1988* (Cth) and any other applicable legislation or privacy guidelines.
- 12.2 **Publicity:** You consent to us using your personal information, including your image, to advertise our Services, including but not limited to mentioning you on our Site and in our promotional material.
- 12.3 **Email:** You acknowledge that we are able to send electronic mail to you and receive electronic mail from you. You release us from any claim you may have as a result of any unauthorised copying, recording, reading or interference with that document or information after transmission, for any delay or non-delivery of any document or information and for any damage caused to your system or any files by a transfer.
- 12.4 **GST:** If and when applicable, GST payable on the Services will be set out on our invoices. By accepting these Terms, you agree to pay us an amount equivalent to the GST imposed on these charges.
- 12.5 **Relationship of parties:** These Terms are not intended to create a relationship between the parties of partnership, joint venture, or employer-employee.
- 12.6 **Assignment:** These Terms are personal to the Parties. A Party must not assign or deal with the whole or any part of its rights or obligations under these Terms without the prior written consent of the other Party (such consent not to be unreasonably withheld).
- 12.7 **Force Majeure:** We will not be liable for any delay or failure to perform our obligations under these Terms if such delay is due to any circumstance beyond our reasonable control. If we are delayed from performing our obligations due to such a circumstance for a period of at least 2 months, we may terminate our agreement with you by giving you 5 Business Days' notice in writing.
- 12.8 **Notices:** Any notice required or permitted to be given by either Party to the other under these Terms will be in writing addressed to the relevant address in the Booking Form. Any notice may be sent by



standard post or email, and notice will be deemed to have been served on the expiry of 48 hours in the case of post, or at the time of transmission in the case of transmission by email.

- 12.9 **Jurisdiction & Applicable Law:** These terms are governed by the laws of New South Wales and the Commonwealth of Australia. Each Party irrevocably and unconditionally submits to the exclusive jurisdiction of the courts operating in New South Wales.
- 12.10 **Entire Agreement:** These Terms and any document expressly referred to in them represent the entire agreement between you and us and supersede any prior agreement, understanding or arrangement between you and us, whether oral or in writing.

### 13. DEFINITIONS

- 13.1 **ACL** means the Australian Consumer Law.
- 13.2 **Business Day** means a day which is not a Saturday, Sunday or bank or public holiday in New South Wales, Australia.
- 13.3 **Departure Date** is set out in the Booking Form.
- 13.4 **Claim/Claims** includes a claim, notice, demand, right, entitlement, action, proceeding, litigation, prosecution, arbitration, investigation, judgment, award, damage, loss, cost, expense or liability however arising, whether present, unascertained, immediate, future or contingent, whether based in contract, tort or statute and whether involving a third party or a party to this Agreement or otherwise.
- 13.5 **Confidential Information** includes confidential information about you, your credit card or payment details, and the business, structure, programs, processes, methods, operating procedures, activities, products and services, trade secrets, know how, financial, accounting, marketing and technical information, customer and supplier lists (including prospective customer and supplier information), ideas, concepts, technology, and other information of either Party whether or not such information is reduced to a tangible form or marked in writing as "confidential".
- 13.6 **Departure Date** is set out in the Booking Form.
- 13.7 **Deposit** is set out in the Booking Form.
- 13.8 **End Date** is set out in the Booking Form.
- 13.9 **Exclusions** are set out in the Booking Form.
- 13.10 **Fees** are set out in the Booking Form.
- 13.11 **GST** means GST as defined in the *A New Tax System (Goods and Services Tax) Act 1999* (Cth) as amended from time to time or any replacement or other relevant legislation and regulations.
- 13.12 **Intellectual Property** includes any and all present and future rights to intellectual and industrial property throughout the world, and includes all copyright and analogous rights, all rights in relation to inventions (including patent rights), patents, improvements, registered and unregistered trademarks, designs, any corresponding property rights under the laws of any jurisdiction, discoveries, circuit layouts, trade names, trade secrets, secret processes, know-how, concepts, ideas, information, processes, data or formulae, business names, company names or internet domain names, and any Confidential Information.
- 13.13 **Invoice Terms** is set out in the Booking Form.
- 13.14 **Materials** means work and materials that we provide to you in carrying out the Services.
- 13.15 **Moral Rights** means the right of attribution of authorship, the right not to have authorship falsely attributed and the right of integrity of authorship, as defined in the *Copyright Act 1968* (Cth).
- 13.16 **Payment Method** is set out in the Booking Form.
- 13.17 **Price** means the Fees for the Services that you have requested, including any Deposit.
- 13.18 **Booking Form** means the booking form to which these Terms are attached.
- 13.19 **Services** means the provision of safari tours and is set out in the Booking Form.

- 13.21 **Terms** means these terms and conditions.
- 13.22 **Variation** means amended or additional services, including but not limited to changes to the Booking Form.
